

## **T&C - TARGET SAILING REGATTA**

**Date:** 26.10.2016 – 29.10.2016

**Organizer & Race Management:** Adria Yacht Center GmbH

**Territory:** Croatian coast and islands around Vodice

**Rules:** The Target Sailing Regatta racing rules are set up in accordance with the International Sailing Federation (ISAF) - the Racing Rules of Sailing 2013-2016 & the Offshore Racing Congress (ORC) simplified by AYC instructions. The races may consist of traditional line start and finish line, target sailing, or a combination of both. Further details see attached in the list of racing rules. There will be a briefing for crews each race day at 09:00 hours.

**Responsibility:** The yacht is fully insured against accidents and third party liability, but responsibility is not accepted for personal accidents, damage or loss due to your negligence. Unnecessary damage and losses attributed to carelessness of a crew member will be paid for by the crew member at replacement price, fair wear and tear accounted for.

**Liability:** All regatta participants sail on their own risk (RRS 4). The organizers and all persons entrusted with the regatta organization will not be liable for any loss, damage or injury that may occur to persons, yachts or otherwise. This applies on the water and onshore.

**Personal Insurance:** You are strongly recommended to arrange your own insurance cover, for cancellation, injury, personal belongings and personal liability.

**Payment conditions:** In order to confirm participation in the Target Sailing Regatta (registration as a single person or as a group [2 or more people] possible), the full payment has to be paid within 1 week after the booking is confirmed from AYC office Vienna (last minute registrations as agreed with AYC Vienna!). The payment is non-refundable once a booking has been received and accepted.

**Cancellation:** if you cancel your participation due to illness, the following cancellation costs shall incur: AYC offers a 50% refund by receiving the cancellation at least one month before the TSR starts by receiving a doctor's certificate to proof the participation in the regatta is not possible.

**Tracking System:** All yachts are equipped with a tracking system (Webeye Monitoring System). The position of the yachts can be tracked during the regatta by the race office.

**Admission:** One-design class Elan 431 without spinnaker & open classes without spinnaker. All skippers need to have the legal requirements for chartering and handling a yacht in Croatia (preferable also knowledge in taking part in a regatta!). By not having a skipper license AYC is offering you (your crew) a skipper taking full responsibility of the boat (at extra charge).

**Engine Use:** The engine may be used for battery charging only!

**Program:** Find below a brief overview and schedule of the AYC Target Sailing Regatta:

- Arrival day: arrival of guests in the afternoon, check in on the boats, welcome buffet and drinks.
- Race day 1: Breakfast followed by skipper briefing; evening meal and presentation of the first day;
- Race day 2: Breakfast followed by skipper briefing; evening meal and presentation of the second day with results and Awards Ceremony;
- Departure day: Check Out by 10 clock;
